## Excellency,

I have the honour to inform you that the International Atomic Energy Agency (IAEA) will hold the Consultancy Meeting of the International Nuclear Data Evaluation Network (INDEN) on the Evaluated Data of the Structural Materials (hereinafter referred to as "event") virtually via Cisco WebEx from 14 to 18 December 2020.

The purpose of the event is to review experimental data and evaluations of structural materials, such as Fe, Cr, Ni and Cu, and to coordinate efforts to improve these evaluations. Of special interest will be the discussion of the energy range between the resolved resonance region and the fast region for elements, such as Fe, which is difficult to describe accurately by both R-Matrix fits and optical models.

The event will be held in English.

I should be grateful if your Government would recommend an expert to be designated by the Secretariat as a participant in the event. The expert should have specialized knowledge of, or experience in, evaluations of structural materials, evaluation methodology in general or experimental techniques to measure the properties of structural materials. In this connection, the Secretariat understands that Mr Wu Haicheng (China Nuclear Data Center, China Institute of Atomic Energy, P.O. Box 275 (41), Beijing 102413, China; Email: haicheng@ciae.ac.cn) could make a valuable contribution to the work of the event and your Government may wish to consider recommending him for this purpose.
